The purpose of this letter is to report the results of the financial monitoring review conducted by the Federal Emergency Management Agency / Region I Grants Management Division from August 7 through August 11, 2023. As you are aware, our grants management staff reviewed the Vermont Emergency Management's documentation for the following grants:

Attachment A Vermont Emergency Management FY23 Financial Monitoring Review

Finding: Contract Provisions

A contract package issued by the Vermont Emergency Management (VEM) in 2022 to SWCA Environmental Consultants was reviewed. As required, the contract provisions included the following:

- Termination for Convenience
- Termination for Cause
- Equal Employment Opportunity
- Davis-Bacon Act
- Contract Work Hours and Safety Standards
- Rights to Inventions Made Under a Contract or Agreement
- Clean Air Act
- Debarment and Suspension
- Byrd Anti-Lobbying Amendment
- Procurement of Recovered Materials

However, the contract provisions did not contain the following:

- Prohibition on Certain Telecommunications and Video Surveillance Services or Equipment (2 CFR 200.216)
- Domestic Preferences for Procurements (2 CFR 200.322)

Recommendation: It is recommended that VEM incorporates these two contract provisions into their standard contract package.

Status: Open, pending a sample standard contract package submitted to FEMA demonstrating the inclusion of these missing contract provisions.

Observation #1: Improvements to Subrecipient Award Package

A FY20 Emergency Management Grant Program subrecipient award package issued by VEM to the Town of Putney was reviewed. While the award package was comprehensive and well organized, FEMA is making the improvement recommendations listed below.

- The subaward Period of Performance Start and End Dates were included, but the Budget Period Start and End Dates were not. It is recommended these dates be incorporated to come into full compliance with 2 CFR 200.332(a).
- There is a "Federal Award Project Description" box on the cover sheet, as required for FFATA reportable subawards. In the sample reviewed, the subaward was not FFATA reportable and the box was left blank. There was an attachment to the subrecipient award package that described the scope of work.
 - By leaving the box blank, it could be inferred that this topic was overlooked. VEM should input either "N/A" or "See Attachment" instead of leaving it blank.

- The Indirect Cost Rate box was left blank. There happened to be no Indirect Costs charged to this subaward. However, it is recommended that VEM inputs "N/A" in these cases instead of leaving it blank to verify that this topic was in fact reviewed, and not disregarded.
- There was a "R&D" box, with a box next to it that could be checked off. Instead of a non-descript box, it is recommended that VEM adds "Yes" and "No" boxes. Again, this will verify review of this topic.
- For the Program Title, VEM used the abbreviation "EMPG". Since inclusion of the Program Title is an explicit requirement, it is recommended that VEM spells out Emergency Management Performance Grant instead of using the abbreviation.

Observation #2: Updated Terminology

FEMA noticed instances throughout VEM's various policies and procedures where the term "CFDA" was not updated to "Assistance Listing". FEMA recommends that these references be updated.

This letter is in response to your findings from the FY 2023 Financial Monitoring Review. In reviewing the contract package issued by the Vermont Emergency Management (VEM) in 2022 to SWCA Environmental Consultants, you noted that there were two contract provisions that this contract did not contain:

- 1. Prohibition on Certain Telecommunications and Video Surveillance Services or Equipment (2 CFR 200.216)
- 2. Domestic Preferences for Procurements (2 CFR 200.322)

These were not included in the contract for SWCA Environmental Consultants because these were not applicable. The procurement didn't include any telecommunications or video surveillance equipment/services (200.216) nor did it include goods, products, or materials (200.322).

If the contract that was reviewed had telecommunication or video equipment/surveillance services, it would have included the proper Attachment D as below:

Since we have compliance measures in place where applicable I respectfully request that the finding for 200.216 be withdrawn.





I have made the Department of Building and General Services Office of Procurement and Contracting aware of the finding for 200.322 and although I haven't had a response yet, I expect a provision will be added to the standard Attachment D to ensure compliance with Domestic Preferences. I will follow up on the outcome of this corrective action by the end of December.

I would also like to thank you for your recommendations. We have reviewed each of these and have begun incorporating all of them into our processes.
