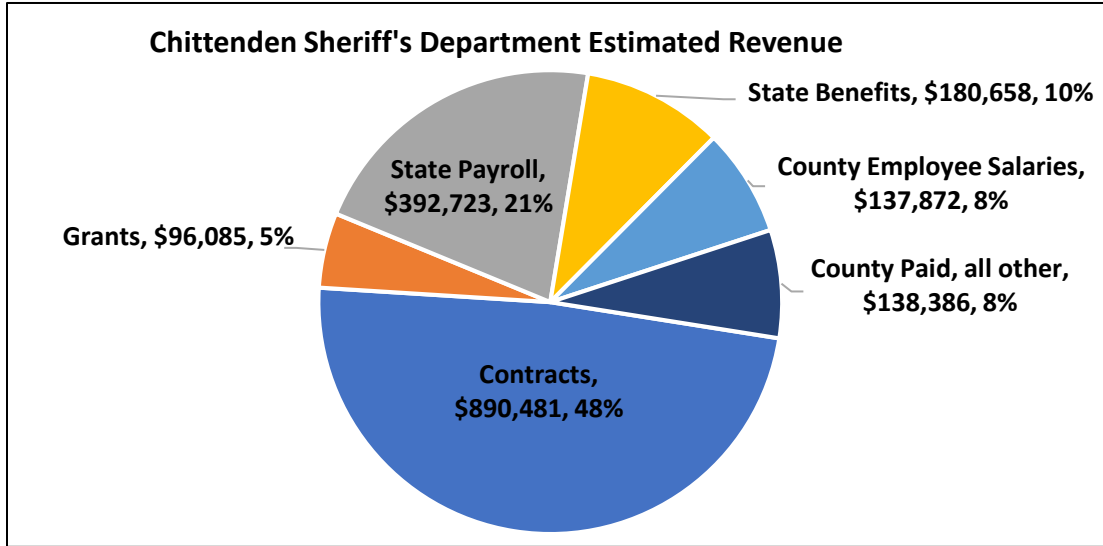


Fiscal Year 2018 Chittenden County Sheriff's Department
