SUBJECT: Contract Increase request of \$124,700

Contract #23700, entered into by the State Auditor's Office, on behalf of the State of Vermont, and by KPMG LLP is amended as follows:

1. **Maximum Amount.** The maximum amount payable under this contract, wherever such references to the maximum amount appear in said contract shall be changed from \$8,403,405 to \$8,528,105. An increase amount of \$124,700.
2. **Contract Term.** The end date wherever such references appear in said contract and its attachments, is unchanged and remains from April 1, 2013 to June 30, 2018.
3. **Attachment A, Scope of Work.** The charges included in this amendment are for out-of-scope work, which the contract allows. See memo dated February 8, 2018, to Susanne Young, Secretary of Administration for additional details on work to be performed (attached).
